Request for Expression of Interest (EOI) For National Consulting Firms

The Government of the Peoples' Republic of Bangladesh (GOB) has received a credit for Haor Infrastructure and Livelihood Improvement Project (HILIP) from the International Fund for Agricultural Development (IFAD) and the Spanish Food Security Co-financing Facility Trust Fund (IFAD Loan No-I-847-BD, IFAD Grant No-I-C-847-BD & Trust Loan No-E-3-BD) and the Local Government Engineering Department (LGED) has been allocated public funds from the GOB toward the cost of the HILIP and intends to apply part of the proceeds of these funds to payments under the contract for the provision of consultancy services for the project by a consulting firm (national).

The services include a **Technical/Impact Study on Roads, Bridges, Culverts and Ghats and markets of HILIP** in haor districts, mainly Netrokona, Kishoreganj, Sunamganj, Hobiganj and Brahmanbaria.

The **objective** of the study is to make details technical study of HILIP intervention and produce documents on the effectiveness of roads, bridges and culverts and landing ghats without negatively impacting the haor environment. The study will also assess the contribution of these investments to encouraging rural economic growth and facilitating employment opportunities for income generation, enhanced access to markets, and social services. A detailed description of services is entailed in the terms of reference (ToR).

The experience, resources and delivery capacity required for the firm are: The consulting firm should have multidisciplinary intellectuals to provide the desired output expected by the procuring entity. The assignment is technical research study oriented and the firm should have study/research capability and already carried out at least 3 similar study assignments. The faculties required to carry out the assignment are the team leader (civil engineer) and other civil engineers related to the above activities. The duration of the assignment is expected to be three (3) months and professional expert staff months are around 12.

The Project Director now invites eligible Applicants to indicate their interest in providing the services. Interested applicants are invited to provide information indicating that they are qualified and competent to perform the services (brochure, description of similar assignments, experience in similar operating conditions, availability of appropriate professional qualifications and experience among staff, etc.). Consultants are requested to submit the following supporting documents in support of the above-mentioned criteria: (a) Registration paper of the firm (s); (b) JV agreement/letter of intent (if applicable); (c) Firm's brochure; (d) Audited financial reports for last three years; (e) service experience record (including nature, total cost, total input in terms of staff-month, employer, location of service etc.) in a prescribed format.

An applicant may associate with other consultant(s) to enhance their qualifications. Association with a foreign firm is not required.

A consultant will be selected using the selection sub-method – Quality and Cost Based Selection (QCBS) following the Public Procurement Rules, 2008. It is expected that the services will be commenced in February 2021 at project areas and shall be completed within three (3) months.
