Request for Expression of Interest (REOI)

The Government of the People's Republic of Bangladesh has applied for a loan from the Japan International Cooperation Agency (hereinafter referred to as "JICA") to finance the **Southern Chattogram Regional Development Project (SCRDP)** which is to improve the living standard and enhance the quality of life in the southern Chattogram region by development of public infrastructure, thereby contributing to the economic development and redress of disparities. The Government of the People's Republic of Bangladesh also intends to use part of the proceeds of the loan for eligible payments for consulting services.

8. EOI is invited from eligible international consulting firms/organizations/institutions in single or in the form of Joint Venture, or association/JVCA, which has required expertise and experience in the above-mentioned areas. The firm would have:
 - (i) Relevant overseas experience of similar development projects for infrastructure subprojects in developing countries, preferably urban subprojects in Asia Pacific and South Asia;
 - (ii) Experience with solid waste management, including planning, designing and implementation of municipal solid waste landfill.
 - (iii) Experience with water supply management, including planning, designing and implementation of production tube well, water supply network and distribution pipelines
 - (iv) Experience with township development, including planning, designing and implementation of facilities related to township.
 - (v) Experience with capacity development of government organizations.
 - (vi) Experience with Japanese ODA loan project.
