**Request for Expression of Interest (EOI) for recruitment of
Project Management and Supervision Consultant (PMSC)

CALL FOR EXPRESSION OF INTEREST (EOI)

1. The Government of the People's Republic of Bangladesh has received a loan from the Asian Development Bank (ADB) for the Coastal Towns Climate Resilience Project (CTCRP) to improve climate and disaster resiliency of coastal towns strengthened including benefitting the poor and women in selected 22 Pourashavas in coastal areas of Bangladesh and intends to apply a portion of the proceeds of this loan to eligible payments under the consultancy services for which this invitation for Expression of interest (EOI) is issued.
2. The overall objective of the assignment is to support the Project Management Unit (PMU) in the LGED for the implementation of the proposed ADB-funded Coastal Towns Climate Resilience Project (CTCRP). It includes (i) ensure high standards of quality assurance in execution and completion of work within stipulated time limit; (ii) comprehensive supervision of project implementation activities carried out by the contractor(s) to ensure complete compliance with the drawings, technical specifications and various stipulations in the contract documents; (iii) monitor safeguards implementation includes environment, social, gender, health and safety activities associated with the project; (iv) prepare & submit the completion report along with of whole project area of 22 Paurashavas considering green building design concept all documents including review & approving as-built drawing to be submitted by the Contractor; and (v) ensure quality control of all construction works by engaging in full time supervision engineering team. LGED invites eligible consulting firm(s) with adequate experience in project management and administration; construction supervision and quality control; and O&M planning and support. The assignment location will be in selected 22 Pourashavas in coastal areas along with 2 (Khulna & Barishal) regions and project HQ of LGED, Bangladesh.
4. It is estimated that the PMSC will require about 12 person-months international as well as 1728 person-months national (1296 person months of key and 432 person months of Non key/ support staff of national consultant) rendered over 84 calendar months from commencement date. The estimated cost is about 43.72 crore BDT (Equivalent \$ 5.08 million USD) excluding VAT and IT. A detailed description of the requirements is provided in the Terms of Reference (TOR) available on the ADB website (<http://csm.adb.org>).
5. The Executing Agency (EA) for the project is LGED under the Local Government Division (LGD) of the Ministry of Local Government, Rural Development and Cooperatives. Eligible consulting firms are invited to express their interest in the assignment. The expression of Interest (EOI) must be submitted online through the ADB's website following the procedures described below.
6. To submit an EOI: (1) register with ADB's Consultant Management System at ADB website (<http://www.adb.org>); click "About ADB", "Consulting Services", and "Consultant Management System;" (2) go to <http://csm.adb.org>; (3) click on "Bangladesh", (4) find the name of the captioned project; and click on "View CSRN;" (5) click on "Express Interest", and (6) follow the instructions. All requested information must be provided in the respective EOI fields completely.
7. The EOI must be submitted online using ADB portal before or on 31-08-2022 (as per ADB CMS time). A consulting firm will be selected in accordance with ADB's quality and cost based selection (QCBS) set out in the ADB Procurement Policy: Goods, Works, Non-consulting and Consulting Services (2017, as amended from time to time) and Procurement Regulations for ADB Borrowers: Goods, Works, Non-consulting and Consulting Services (2017, as amended from time to time).
