The Government of the People's Republic of Bangladesh has received financing from the Asian Development Bank (ADB) towards the cost of **Second City Region Development Project**, and part of the proceeds of this financing will be used for payments under the contract named above. Bidding is open to all Bidders from eligible source countries of the ADB.
2. The Local Government Engineering Department (“the Employer”) invites sealed bids from eligible bidder for the procurement of the following Goods:

3. **International Competitive Bidding (ICB)** will be conducted in accordance with ADB's **Single – Stage: One-Envelope** bidding procedure and is open to all Bidders from eligible source countries mentioned in the Section 5 of the Bidding Document.
4. Only eligible Bidders with the following key qualifications should participate in this bidding:
 - Contractual Experience: Successful completion as main supplier within the last **3 (three)** years, of at least **1 (one)** contract with a value of **USD 1.50 million** with nature, and complexity similar to the scope of supply described in Section 6 (Schedule of Supply).
 - Size of Operation (Average Annual Turnover): Minimum average annual turnover of **USD 3.80 million** calculated as total payments received by the Bidder for contracts completed or under execution over the last **3 (three)** years.
 - Cash Flow Capacity: Availability of or access to liquid assets, lines of credit, and other finances sufficient to meet cash flow requirement which is **USD 0.50 million**.
