The Government of the People's Republic of Bangladesh has received financing from the World Bank toward the cost of the Western Economic Corridor & Regional Enhancement Program (WeCARE) Phase-I and intends to apply part of the proceeds for Land Acquisition Resettlement and Income Restoration Specialist.

The broad scope of consulting services ("the Services") includes carrying out the following in the project influence areas of Jashore, Jhenaidah, Magura, Chaudanga, Satkhira, and Meherpur.

- 1. Assist the Project Implementation Unit (PIU) with land acquisition documentation and resettlement action plan preparation with help of the firm deployed for these tasks.
- 2. Check all associated reports, data, and procedure as instructed by Project Implementation Unit (PIU).
- 3. Ensure that the resettlement and income restoration are conducted in accordance with GoB and WB policies but at the same time aids with timely implementation of the project.

The expected date for commencement of the services is February 2021 and the tentative duration of the entire assignment is about 52 (Fifty Two) months. A draft TOR can be found at the following website: (www.lged.gov.bd or can be obtained at the address given below).
